Ballot Box Report

Ballots were picked up on the west side January 30th and countywide February 4th. Due to inclement weather, the west side ballot pickup scheduled for February 8th and the countywide ballot pickup scheduled for February 11th were cancelled.

Ballot collection bags and keys for election night needed to be delivered to Bingen and Klickitat on February 12th for election night closing and the Roosevelt and Bickleton boxes needed to be closed. Our office reached out to the Sheriff's Department for assistance and Eric Anderson responded. Officer Anderson drove to Bingen and Klickitat to deliver collection bags and then drove out to Bickleton and Roosevelt to close the boxes around 2:30 p.m. Ballot box closing time is 8:00 p.m., but due to there being no election in Bickleton and Roosevelt and the dangerous road conditions, the Auditor chose to have the boxes closed early. Upon Anderson's return, he reported that there was snow around both boxes and there were no footprints around either box.

Going forward, when an election occurs during snowy conditions a work order will be submitted requesting that each ballot box location be plowed out and the date range effecting the election. This is the first election where snow removal was a factor.
