Brandie distributed results of the February 13, 2018, Special Election which showed a 42.35% return 2589 ballots returned. All levies passed with the exception of Roosevelt School District at this time, there is 2 votes difference with the "No's" ahead.

7 LP Ballots, were rejected by the board. (List is attached)

2 Pink envelopes were found in the Goldendale Office Drop Box, they were opened in front of the board to make sure there were no identifying marks on the ballots and then rejected by the board.

1 Pink envelope was found upon opening that contained two ballots, both voted the same this was discussed and the decision was made to count one ballot and reject one ballot. Serial #900003090182 Accepted and Serial #800003089120 Rejected.

Brenda presented the board with 4 ballots that were found in the Goldendale Drop Box after the 8:00 p.m. closure Election night. It had been brought to her attention that the box had not been properly closed the night of the Election and after further investigation the 4 ballots were found (Driver, Linda J., Lichtenwald, Daniel Henry, Runyan, Dawn M., Goodman, Danielle). The board was assured that these ballots must have been dropped into the box after 8:00 p.m. Election night, so the board rejected these ballots along with the request of further documentation being written for them to sign at the Certification Meeting on February 23rd.
