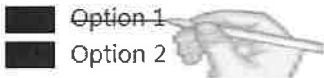

Hospital District # 1 Proposition No. 1

Bonds for Hospital Facilities and Equipment

The Commission of Public Hospital District No. 1, Klickitat County, Washington, adopted Resolution No. 2019-06 concerning a proposition to finance improvements to Klickitat Valley Health. This proposition would authorize the District to construct, equip and furnish a two-story addition to Klickitat Valley Health's hospital facility, originally built in 1949, to expand the hospital's inpatient acute care, surgery, pharmacy, and nutrition services and community education, and carry out other capital improvements; issue no more than \$18,895,000 of general obligation bonds maturing within 30 years; and levy annual excess property taxes to repay the bonds, all as provided in Resolution No. 2019-06. 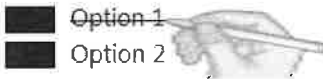
